The MoHAP named-patient coordination pathway — indicative 2026

The clinical situation

Bimzelx (bimekizumab-bkzx) is a subcutaneous dual IL-17A and IL-17F inhibitor monoclonal antibody FDA-approved for moderate-to-severe plaque psoriasis, psoriatic arthritis, axial spondyloarthritis, and hidradenitis suppurativa. Manufactured by UCB. The induction-maintenance calendar is indication-specific (typical psoriasis maintenance: 320 mg SC every 8 weeks). Pre-treatment workup covers TB screening, hepatitis B/C, oral candidiasis risk review, IBD screening, and vaccination status per FDA labelling.

The pathway, 5 steps

- 1 Consultation & clinical rationale.** Your dermatologist or rheumatologist documents indication, severity, prior biologics, and Bimzelx rationale.
- 2 Baseline screening.** TB, hepatitis B/C, IBD review, oral-candidiasis counselling, and vaccination status per FDA labelling.
- 3 MoHAP named-patient application.** Physician or hospital pharmacy files clinical rationale, patient reference, dosing calendar, and chain-of-custody plan; DHA or DoH approvals align where applicable.
- 4 US-side sourcing & cold-chain logistics.** Reserve Meds coordinates product through our US-licensed DSCSA-compliant specialty wholesale partner with validated 2–8°C shipment.
- 5 Arrival & first dose.** Dispensing pharmacy releases product against the prescription; your physician initiates therapy with ongoing IL-17 class monitoring.

Indicative economics
