The MoHAP cross-border QTC referral pathway — indicative 2026

RARE DISEASE · CRISPR GENE THERAPY SCD/TDT

The clinical situation

Casgevy (exagamglogene autotemcel) is a one-time infusion of CRISPR-Cas9-edited autologous haematopoietic stem cells for severe sickle cell disease and transfusion-dependent beta-thalassemia. Developed by Vertex Pharmaceuticals and CRISPR Therapeutics. The editing disrupts a BCL11A regulatory region to reactivate foetal haemoglobin. Treatment involves mobilisation, apheresis, a multi-week manufacturing window, myeloablative conditioning, infusion, and extended inpatient engraftment recovery at an authorised Qualified Treatment Centre (QTC).

The pathway, 5 steps

- 1 Consultation & eligibility.** Haematologist confirms severe SCD or TDT diagnosis, crisis/transfusion history, organ-system baseline, and fitness for myeloablative conditioning.
- 2 QTC referral.** Reserve Meds coordinates cross-border referral to a Casgevy-qualified centre via our international care-coordination network.
- 3 MoHAP / DoH / DHA cross-border medical-referral dossier.** Your physician files the referral with rationale, QTC identification, and return-home follow-up plan.
- 4 Mobilisation, apheresis & manufacturing.** Conducted at the QTC; several-week manufacturing window; bridging transfusion support locally or at the QTC.
- 5 Conditioning, infusion & engraftment.** QTC inpatient stay 4–6+ weeks; handover to your UAE haematologist for long-term follow-up.

Indicative economics

Reference US list price: USD 2.0–2.3M one-time for the gene-therapy product; total cost of care at a US QTC typically runs substantially higher (drug-only reference; Reserve Meds provides a transparent delivered quote at intake).

Indicative first-dose timing

12–24 weeks from intake to infusion, driven by the manufacturing window and QTC calendar. Inpatient stay 4–6+ weeks. Indicative — not guaranteed.
