The MOPH named-patient coordination pathway — indicative 2026

RARE DISEASE · MPS II (HUNTER SYNDROME)

The clinical situation

Elaprase (idursulfase) is an FDA-approved recombinant iduronate-2-sulfatase enzyme replacement therapy for Hunter syndrome (MPS II), dosed 0.5 mg/kg IV weekly. Manufactured by Takeda. Weight-based dosing, cold-chain shipment, and multisystem monitoring (airway, cardiac, skeletal) are required. Infusion-related reactions are managed with premedication and rate titration.

The pathway, 5 steps

- 1 Consultation & diagnostic confirmation.** Treating metabolic specialist confirms IDS enzyme deficiency and Hunter phenotype; weight-based weekly dose calculated.
- 2 Infusion centre confirmed.** A Qatari tertiary centre (Doha) commits to weekly infusion slots and multisystem monitoring.
- 3 MOPH named-patient application.** Clinical rationale, enzyme assay, dose calculation, and product details are filed with MOPH for import clearance.
- 4 US-side sourcing & cold-chain logistics.** Reserve Meds coordinates product through our US-licensed DSCSA-compliant specialty wholesale partner; refrigerated shipment booked to weekly schedule.
- 5 Infusion & monitoring.** Weekly IV infusions under specialist supervision; airway, cardiac, and skeletal monitoring per label.

Indicative economics

Reference US cash-pay range: USD 30,000–40,000 per month (weight-based) drug-only. Cold-chain logistics, MOPH documentation, infusion-centre fees, and concierge coordination are incremental. Full transparent quote at intake.

Indicative first-infusion timing

7–14 days from a complete MOPH application to first-infusion delivery, once cohort intake opens. Indicative — not guaranteed.
