The MoHAP named-patient coordination pathway — indicative 2026

The clinical situation

Elfabrio (pegunigalsidase alfa) is an FDA-approved PEGylated recombinant alpha-galactosidase A enzyme replacement therapy for adults with Fabry disease, dosed 1 mg/kg IV every two weeks. Manufactured by Chiesi / Protalix. Weight-based dosing, cold-chain shipment, and renal / cardiac monitoring are required; infusion-related reactions are managed with premedication and rate adjustment.

The pathway, 5 steps

- 1 Consultation & diagnostic confirmation.** Treating metabolic / genetics specialist confirms GLA variant and Fabry phenotype; weight-based dose calculated, renal and cardiac baselines documented.
- 2 Infusion centre confirmed.** A UAE tertiary centre (Abu Dhabi or Dubai) commits to biweekly infusion slots and monitoring.
- 3 MoHAP named-patient application.** Clinical rationale, genetic report, dose calculation, and product details are filed for MoHAP review.
- 4 US-side sourcing & cold-chain logistics.** Reserve Meds coordinates product through our US-licensed DSCSA-compliant specialty wholesale partner; refrigerated shipment booked to infusion schedule.
- 5 Infusion & monitoring.** Biweekly IV infusions under specialist supervision; renal function and cardiac imaging monitored per label.

Indicative economics

Reference US cash-pay range: USD 18,000–24,000 per infusion (weight-based) drug-only. Cold-chain logistics, MoHAP documentation, infusion-centre fees, and concierge coordination are incremental. Full transparent quote at intake.

Indicative first-infusion timing

7–14 days from a complete MoHAP application to first-infusion delivery, once cohort intake opens. Indicative — not guaranteed.
