



# Evrysdi in UAE

*The MoHAP named-patient coordination pathway — indicative 2026*

## The clinical situation

Evrysdi (risdiplam) is an oral SMN2 pre-mRNA splicing modifier for spinal muscular atrophy across all ages, including infants from birth. Manufactured by Roche/Genentech. Supplied as an oral solution reconstituted by pharmacy; dose is weight- and age-titrated, taken once daily after a meal. Embryo-fetal toxicity requires contraception counselling. Lifelong therapy; gaps in supply reduce motor and respiratory benefit.

### The pathway, 5 steps

- 1 Consultation & SMN1 genotyping.** Your neurology team confirms biallelic SMN1 mutation, SMN2 copy number, age, and weight for dose calculation.
- 2 Baseline assessment.** Motor milestone scoring (CHOP-INTEND/HFMSE/RULM), respiratory baseline, and contraception counselling where applicable.
- 3 MoHAP named-patient application.** Clinical rationale, genotype report, and dosing plan filed under personal-use import.
- 4 US-side sourcing & logistics.** Reserve Meds coordinates refills through our US-licensed DSCSA-compliant specialty wholesale partner; refrigerated cold-chain of reconstituted product.
- 5 Initiation & continuity.** Neurology team initiates and trains the family on reconstitution and dosing; continuity planning for lifelong supply.

### Indicative economics

### Indicative first-dose timing
