



# Gavreto in India

*The CDSCO named-patient coordination pathway — indicative 2026*

## The clinical situation

Gavreto (pralsetinib) is a selective oral RET kinase inhibitor. Manufactured by Blueprint Medicines. Eligibility requires molecular confirmation of a RET fusion by next-generation sequencing; dosing is typically 400 mg once daily on an empty stomach, with monitoring for hypertension, pneumonitis, liver enzymes, haemorrhage, and cytopenias.

### The pathway, 5 steps

- 1 Consultation & clinical rationale.** Your treating oncologist confirms RET fusion status and documents a written clinical rationale.
- 2 Administering facility confirmed.** An Indian tertiary oncology centre or licensed personal-use receiver is identified.
- 3 CDSCO named-patient application.** Clinical rationale, prescription, patient reference, product details, and chain-of-custody plan are filed.
- 4 US-side sourcing & logistics.** Reserve Meds coordinates product through our US-licensed DSCSA-compliant specialty wholesale partner.
- 5 Arrival & administration.** The pharmacy releases product against prescription; concierge coordinates monthly re-supply ahead of cycle end.

### Indicative economics

### Indicative first-dose timing

**7–14 days** from a complete CDSCO application to first delivery, once cohort intake opens. Indicative — not guaranteed.
