



# Rinvoq in the UAE

*The MoHAP named-patient coordination pathway — indicative 2026*

## The clinical situation

Rinvoq (upadacitinib) is an oral, once-daily selective JAK1 inhibitor FDA-approved for rheumatoid arthritis, psoriatic arthritis, atopic dermatitis, ulcerative colitis, Crohn's disease, and axial spondyloarthritis. Manufactured by AbbVie. Dosing is indication-specific (15 mg, 30 mg, or 45 mg induction per labeling). Pre-treatment workup covers TB, hepatitis B/C, lipid panel, CBC, and LFTs. The FDA JAK-class boxed warning on serious infections, malignancy, MACE, and thrombosis applies; your physician performs the risk-benefit assessment.

### The pathway, 5 steps

- 1 Consultation & clinical rationale.** Your rheumatologist, dermatologist, or gastroenterologist documents indication, severity, prior therapies, and Rinvoq rationale.
- 2 Baseline screening.** TB, viral hepatitis, lipid panel, CBC, LFTs, and vaccination status are completed and documented per FDA labeling.
- 3 MoHAP named-patient application.** Physician or hospital pharmacy files clinical rationale, patient reference, strength, quantity, and chain-of-custody plan; DHA or DoH approvals align where applicable.
- 4 US-side sourcing & logistics.** Reserve Meds coordinates product through our US-licensed DSCSA-compliant specialty wholesale partner with tamper-evident international shipment.
- 5 Arrival & first dose.** Dispensing pharmacy releases product against the prescription; your physician initiates therapy with ongoing JAK-class monitoring.

### Indicative economics
