The SFDA named-patient coordination pathway — indicative 2026

The clinical situation

Spinraza (nusinersen) is an antisense oligonucleotide modulating SMN2 splicing for spinal muscular atrophy across the paediatric and adult age spectrum. Manufactured by Biogen. Delivered by intrathecal injection 12 mg: four loading doses at days 0, 14, 28, and 63, then maintenance every four months for life. Requires a qualified interventional team; platelets and coagulation are monitored given post-lumbar puncture bleeding risk.

The pathway, 5 steps

- 1 Consultation & SMN1 genotyping.** Your neurology team confirms biallelic SMN1 deletion/mutation and documents motor and respiratory baseline.
- 2 Baseline assessment.** Platelet count, coagulation profile, renal function, and spine imaging to plan intrathecal access.
- 3 SFDA named-patient application.** Clinical rationale, genotype report, and planned intrathecal-administration centre filed under personal-use import.
- 4 US-side sourcing & logistics.** Reserve Meds coordinates dose-by-dose supply through our US-licensed DSCSA-compliant specialty wholesale partner.
- 5 Administration & continuity.** Interventional neurology/radiology team performs intrathecal dosing on schedule; platelet/coagulation monitoring per FDA labelling.

Indicative economics

Reference US cash-pay range: USD 125,000–140,000 per 12 mg dose; Year 1 typically 6 doses (drug-only reference; Reserve Meds provides a transparent delivered quote at intake).

Indicative first-dose timing

7–14 days from a complete SFDA application to first dose, once cohort intake opens. Indicative — not guaranteed.
