The MoHAP named-patient coordination pathway — indicative 2026

The clinical situation

Tremfya (guselkumab) is a subcutaneous anti-IL-23 (p19) monoclonal antibody FDA-approved for moderate-to-severe plaque psoriasis, psoriatic arthritis, ulcerative colitis, and Crohn's disease. Manufactured by Janssen. Typical maintenance is 100 mg SC every 8 weeks after loading doses; IBD uses IV induction followed by SC maintenance. Pre-treatment workup covers TB screening, hepatitis B/C, vaccination status, and baseline infection review per FDA labelling.

The pathway, 5 steps

- 1 Consultation & clinical rationale.** Your dermatologist, rheumatologist, or gastroenterologist documents indication, severity, prior biologics, and Tremfya rationale.
- 2 Baseline screening.** TB, hepatitis B/C, vaccinations, and infection review completed and documented per FDA labelling.
- 3 MoHAP named-patient application.** Physician or hospital pharmacy files clinical rationale, patient reference, strength, calendar, and chain-of-custody plan; DHA or DoH approvals align where applicable.
- 4 US-side sourcing & cold-chain logistics.** Reserve Meds coordinates product through our US-licensed DSCSA-compliant specialty wholesale partner with validated 2–8°C shipment.
- 5 Arrival & first dose.** Dispensing pharmacy releases product against the prescription; your physician initiates therapy with ongoing IL-23-class monitoring.

Indicative economics

Reference US cash-pay range: USD 20,000–24,000 per quarterly Tremfya maintenance dose (drug-only reference; Reserve Meds provides a transparent delivered quote at intake).

Indicative first-dose timing

7–14 days from a complete MoHAP application to first dispensation, once cohort intake opens. Indicative — not guaranteed.
