The SFDA named-patient coordination pathway — indicative 2026

RARE DISEASE · CYSTIC FIBROSIS CFTR MODULATOR

The clinical situation

Trikafta (elexacaftor/tezacaftor/ivacaftor) is a triple-combination CFTR modulator for cystic fibrosis patients aged 2 years and older with at least one F508del mutation or another responsive CFTR variant. Manufactured by Vertex. Oral once-daily morning tablets plus an evening ivacaftor dose. Transaminase monitoring and paediatric cataract screening are required. Lifelong therapy; treatment gaps rapidly reverse pulmonary gains.

The pathway, 5 steps

- 1 Consultation & CFTR genotyping.** Your CF team confirms F508del or other responsive variant and writes the clinical rationale letter.
- 2 Baseline assessment.** Liver function, sweat chloride where useful, pulmonary function, and cataract screening for paediatric patients.
- 3 SFDA named-patient application.** Rationale, genotype report, patient reference, and dosing plan filed under personal-use import.
- 4 US-side sourcing & logistics.** Reserve Meds coordinates product through our US-licensed DSCSA-compliant specialty wholesale partner.
- 5 Initiation & monitoring.** Your CF team initiates; transaminases at baseline, 3, 6, and 12 months; continuity planning for lifelong supply.

Indicative economics
