The clinical situation

Voxzogo (vosoritide) is a C-type natriuretic peptide analogue that improves linear growth in children with achondroplasia whose epiphyses are open. Manufactured by BioMarin. Daily subcutaneous home injection by trained caregiver. Eligibility anchors to FGFR3-confirmed achondroplasia and open epiphyses on imaging; dosing is weight-based. Ongoing paediatric-endocrinology or genetics oversight with height/growth-velocity tracking and post-injection blood-pressure monitoring.

The pathway, 5 steps

- 1 Consultation & clinical rationale.** Paediatric endocrinologist or geneticist confirms achondroplasia (FGFR3), baseline auxology, open-epiphysis imaging, and cardiovascular baseline.
- 2 Caregiver injection training.** Care team schedules subcutaneous-injection training and BP-observation protocol.
- 3 MoHAP named-patient application.** Physician or hospital pharmacy files rationale, genetic report, patient reference, and chain-of-custody plan (DoH/DHA jurisdictions apply).
- 4 US-side cold-chain sourcing.** Reserve Meds coordinates product through our US-licensed DSCSA-compliant specialty wholesale partner with cold-chain shipment.
- 5 Arrival & dispensing.** Hospital pharmacy releases monthly supply; paediatric team schedules monthly clinic reviews for growth velocity and BP surveillance.

Indicative economics
