RARE DISEASE · AAV9 GENE THERAPY FOR SMA

The clinical situation

Zolgensma (onasemnogene abeparvovec-xioi) is a one-time AAV9-based gene therapy for paediatric spinal muscular atrophy (biallelic SMN1 mutations) in patients under two years of age. Manufactured by Novartis. Administered as a single weight-dosed intravenous infusion. Prednisolone is initiated one day before infusion and tapered over approximately two months. Transaminase, platelet, and troponin monitoring are required weekly for the first month then on schedule.

The pathway, 5 steps

- 1 Consultation & SMN1 genotyping.** Your paediatric neurology team confirms biallelic SMN1 mutation, weight, age, and anti-AAV9 antibody status (titre <1:50 required).
- 2 Baseline assessment.** Transaminases, platelets, troponin-I, CHOP-INTEND or HINE-2 motor milestone scoring, and infection screen.
- 3 MoHAP named-patient application.** Clinical rationale, genotype report, weight, and infusion-centre attestation filed under personal-use import.
- 4 US-side sourcing & cold-chain logistics.** Reserve Meds coordinates the dose through our US-licensed DSCSA-compliant specialty wholesale partner; deep-frozen cold-chain to the infusion centre.
- 5 Infusion & post-dose monitoring.** Paediatric team infuses at a qualified centre; weekly labs month 1, then tapered per FDA labelling.

Indicative economics

6–10 weeks from a complete MoHAP application to infusion, once cohort intake opens. Indicative — not guaranteed.
